In compliance with article 74 § 7 of the Law of 1 April 2007 on public take-over bids (the “Law”) we informed you on 18/02/2008 that a number of parties acting in concert jointly held more than 30 % of the voting securities issued by Etablissements Fr. Colruyt N.V. (the “Company”) on 1 September 2007.

Please find herewith an update as per 27/08/2015 of the different shareholdings in conformity with article 74 § 8 of the law mentioned above.

On 13 July 2015, the NV DIM, the NV HIM, the NV HIM Drie, the NV DHAM and the NV KORYS were merged. As a result, all the shares of these companies are now the property of NV KORYS.

This notification is sent to you in the name and on account of all parties acting in concert.
