

Regulations

By entering, the participant declares to agree with the regulations below.

What?

Colruyt Group organises a running and walking tour "#ColruytGroupie Run" around and in the Colruyt Group buildings in Halle on Sunday 18 June 2017, from 9 am to 3 pm. The track is about 6.5 km long.

Who

The running and walking tour is for co-workers (i.e. employees who have an employee number) of Colruyt Group and family members living with them.

Minors can only participate if they have the explicit authorisation of both their parents or their guardian. If a minor participates in the tour, Colruyt Group assumes he/she has the authorisation fo his/her parents/guardian.

Entry

In order to participate in the #ColruytGroupieRun, you have to enter online in advance.

Only Colruyt Group co-workers (i.e. employees who have an employee number) can enter.

You can enter on website <https://run.colruytgroup.com> until 1 May 2017.

The organiser reserves the right to close entries earlier if he deems it necessary.

The entry fee is 10 € (including VAT). Your entry is valid only after payment of the entry fee.

The total sum of the entry fee is in aid of the education projects of Colibri Foundation.

Moreover, Colruyt Group will double the sum.

If you cannot participate, regardless of the reason, you cannot claim the reimbursement of the entry fee.

If the event cannot take place because of exceptional circumstances, the organisation cannot be forced to reimburse the entry fee.

When entering, the Colruyt Group participant chooses one of the following options:

- To run the track (only for co-workers)
- To run the track (only for co-workers) and after the finish to explore it again walking. If desired, family members who live with them can accompany them on the walk. The co-worker mentions the number of family members.
- To explore the track walking. If desired, family members who live with them can accompany them on the walk. The co-worker mentions the number of family members.

When the participant enters, there is another option, namely to specify whether or not he wants a T-shirt. When you enter, you choose either a men's or women's T-shirt and the size. 1 entry entitles you to 1 T-shirt.

Based on her/his personal email address, the participant receives an email with her/his e-ticket mentioning a bar code. Bring this ticket with the bar code on the day of the event - it is your admission and participation ticket.

Proceeds in aid of Collibri Foundation

The entry fee is in aid of the education projects of Collibri Foundation.

The total entry proceeds are doubled by Colruyt Group and paid into the account of Collibri Foundation that is managed by the King Baudouin Foundation.

All additional proceeds from the sale of food and/or drinks during the event are also paid in aid of the education projects of Collibri Foundation (www.collibrifoundation.org)

Participation

Participants should present their e-ticket (= the email they received after entering and paying the entry fee mentioning the bar code).

When handing in the e-ticket on the day of the event, the participant receives a number with integrated chip and a "#ColruytGroupieRun" T-shirt according to the specifications mentioned on the e-ticket.

Each bar code is good for 1 T-shirt.

The dressing rooms are only open to people who have a number. The organisers are not liable in case of loss or theft.

The number must be worn during the entire tour.

Participating in the "#ColruytGroupieRun" is at your own risk.

Participation requires good health. The participant declares meeting this condition. The organisation recommends a preventive physical sports exam with an accredited sports doctor before participating.

The organisation is not liable for loss and/or theft of personal objects of the participant.

Bicycles, motorised vehicles and roller blades that are not of the organisation, are forbidden on the track during the "#ColruytGroupieRun".

Buggies are welcome.

The Red Cross provides medical assistance along the track.

Colruyt Group has accident insurance for physical injury suffered during the event.

Participation implies unconditional acceptance of these regulations. No dispute about them can be taken into consideration. Complaints have to be sent in writing within 7 working days after the end of the period to the registered office of Etn. Franz Colruyt, Edingensesteenweg 196, 1500 Halle. Complaints shall not be handled orally or by telephone. Late complaints or complaints that have not been filed in writing, will not be considered.

These regulations are governed by Belgian law. Only the courts of Brussels shall have competent jurisdiction for all disputes concerning their application.
